The citation issued to you by the Maypearl Police Department will result in a complaint being filed against you in this court. IF YOU FAIL TO RESPOND TO THE CHARGES BY THE APPEARANCE DATE ON THE CITATION, AN ADDITIONAL CHARGE WILL BE FILED FOR VIOLATE WRITTEN PROMISE TO APPEAR AND THE DEPARTMENT OF PUBLIC SAFETY WILL DENY RENEWAL OF YOUR DRIVER'S LICENSE. A juvenile who fails to appear with legal guardian by the appearance date on the citation may have their license suspended as required by law.

NON-RESIDENT VIOLATORS: If you have a driver's license from a state that is a member of the Non-resident violator compact, failure to comply with requirements set forth in the citation will result in your license being suspended in your home state.

OPTION 1. PAYMENT OF FINE X

To avoid the fee, follow the instructions below and mail in your payment.

I hereby enter a plea of NOT GUILTY and request a trial before the Judge. *You will be notified by email of your pretrial date. Also use if under 17.*

OPTION 3. REQUEST FOR DEFERRED DISPOSITION (PROBATION) X _____

Eligibility Requirements for Deferred Disposition

You must request Deferred Disposition on or before the appearance date on your citation. You must not receive another citation in the City of Maypearl within the probationary period (60 days). You must pay all amounts due as ordered or scheduled. If you are under the age of 25, you are required by law to complete a driving safety course approved under Chapter 1001, Education Code.

YOU ARE NOT ELIGIBLE FOR DEFERRED DISPOSITION OF YOU: HOLD A COL, ARE 25 MILES OVER THE POSTED SPEED LIMIT, OR SPEEDING IN A SCHOOL OR WORK ZONE

I hereby enter a plea of GUILTY or NO CONTEST (CIRCLE ONLY ONE) and waive my right to a trial appearance. I would like to request Deferred Disposition to keep the citation off my driving record. Please enclose a check or money order in the amount of your fine plus an additional \$40.00 administrative fee (for each violation) made payable to Maypearl Municipal Court, *YOU WILL RECEIVE CORRESPONDENCE FROM THE COURT VIA MAIL.*

OPTION 4. REQUEST FOR DRIVING SAFETY COURSE (SIGN AND NOTARIZE BOTTOM OF FORM)

A DRIVING SAFETY COURSE MAY DISMISS ONE MOVING VIOLATION PER YEAR. *IF YOU HAVE MULTIPLE VIOLATIONS, YOU MAY ALSO REQUEST DEFERRED DISPOSITION.*

The following affidavit must be completed, signed, and notarized. Failure to submit request on or before your appearance date will result in ineligibility for a driving safety course. You are required to pay the court cost of \$144.00 instead of the total citation amount.

YOU ARE NOT ELIGIBLE FOR A DRIVING SAFETY COURSE IF YOU: HOLD A CDL, ARE 25 MILES OVER ANY POSTED SPEED LIMIT (OR DRIVING MORE THAN 94 IN A 75 MPH ZONE), OR SPEEDING IN A SCHOOL OR WORK ZONE.

ELIGIBILITY REQUIREMENTS FOR DRIVING SAFETY (YOU MUST BE ABLE TO ANSWER TRUE TO THE STATEMENTS BELOW IN ORDER TO BE ELIGIBLE)

- ☐ I possess a TEXAS driver's license.
- ☐ I have NOT taken a Driving Safety Course in the past 12 months nor am I presently enrolled in a safety course to have a traffic citation dismissed.
- ☐ I have enclosed a copy of my personal auto insurance.
- ☐ I have enclosed a CHECK OR MONEY ORDER in the amount of \$144.00 made payable to Maypearl Municipal Court.

I hereby enter a plea of GUILTY or NO CONTEST (CIRCLE ONLY ONE) and waive my right to a trial appearance. I would like to request Driving Safety Course to keep the citation off my driving record. *YOU WILL RECEIVE CORRESPONDENCE FROM THE COURT VIA MAIL.*

Once above requirements are met, it is up to the defendant to locate, register, and complete the course. You will have 90 days from your approval date to complete a Driver's Safety Course and provide the court with the original certificate of completion and a copy of your 3A driving record.
